UNDERTAKING Relating to the season ticket parking PASS for tourist coaches

The City of Paris makes available a PASS Autocar to coach companies, providing them with access to most coach parks and to all parking spaces reserved for coaches on public roads.

These PASS Autocar are intended to encourage and facilitate systematic use by drivers of parking spaces reserved for tourist coaches. The aim is to limit inconvenience to residents and nuisance from traffic or stationary vehicles.

In exchange for the financial advantage granted by the City of Paris through the season ticket parking PASS, companies subscribing to it undertake to respect various principles and regulations.

would like to benefit from the season ticket parking PASS

For this, it undertakes to:

- Participate actively in the consultation process initiated by the City of Paris for the implementation of service conditions for Parisian tourist sights, taking into account respect for residents;
- Integrate measures related to traffic and parking once the programme and the price of the tourist service proposed to clients have been established;
- Require coach drivers under their authority to respect the regulatory measures in force in Paris, i.e. mainly:
 - o No parking in Paris outside the spaces reserved for coaches,
 - o No stopping outside the spaces provided for this purpose within the "tourist areas" defined by orders by the Mayor of Paris and the Police Commissioner,
 - o No stopping for more than 15 minutes for passenger boarding and exit or for loading and unloading luggage outside tourist areas,
 - o No driving in bus lanes and in some roads or areas of Paris as defined by order,
 - o Obligation to stop the vehicle engine when stopping or parking at all times.
- In order to limit air pollution, in Paris only use coaches with a EURO standard at least equal to the third last EURO standard in relation to the one in force. On 1st January 2014, no coach with a standard previous or equal to the EURO 3 standard, dating from October 2000, may from that date on hold a season ticket;

In the event of the company's non-compliance with this undertaking, the advantage of the season ticket parking PASS may be suspended for 3 months, then permanently for repeated offences. The company will be informed of this by registered letter with acknowledgment of receipt after a first warning letter.
